#### The Eyes Right parade of cheques totaled \$13,475.99.

Vice -Chair Lion Harry Wismer presented the final payment of \$11, 344.18 for the new Yag laser at the St. Thomas Elgin General Hospital to Dr. Lori Teeple, head of the emergency department. The total cost of the laser was \$31,344.18 which the Lions family of A-1 paid for in one year.

## **Old Business**

Lions:

As per DG Don's request I am requesting the funds received as part of the settlement of the Westmount Lions, which I understand will be approximately \$4,000.00, be donated to the St Joseph's Health Care Foundation in support of the expansion of the Ivey Eye Institute at St. Joseph's Hospital in London.

The 6 London clubs (includes Lambeth as they are in London but not part of Zone 2 North) are in unanimous agreement that this is where we would like to see the funds go. Since the funds were initially raised in London the clubs feel the recovered amount should be returned to London.

Although this facility is located in London it should be noted the Ivey Eye Institute draws patients from several Districts, including:

--A-1: 20,634 patients (68% of total); and 57,187 patient visits (66% of total)

--A-15: 3,263 patients (11% of total); 10,473 patient visits (12% of total)

--A-711: 712 patients (2% of total); 2186 patient visits (3% of total).

As you can see, the majority of the patients treated come from District A-1 which, in essence, makes this a District area contribution.

The Ivey Eye Institute is a Canadian leader in the delivery of specialized clinical and surgical eye care. It offers emergency eye care 24 hours a day and treats patients ranging from newborns to seniors. It also provides training to residents and fellows, the next generation of caregivers, and conducts research to help future eye care.

The new space will feature bright, spacious clinical areas equipped with state-of-the-art technology. It will have a diagnostic and screening centre for specialized patient tests, a comprehensive patient resource and education centre, specialized procedure rooms for minor interventions and a cataract suite to ease long waiting lists for cataract surgery. We therefore request cabinet approve donating of these funds as requested above. Respectfully,
