**A Candidate for the office of District Governor shall**

1. Be an active member in good standing of a chartered Lions Club in good standing in his/her Single or Sub-District.
2. Secure the endorsement of his/her Club or the majority of the Clubs in his/her Single or Sun-District.
3. Have served or will have served by the time he/she takes office as District Governor:
  - a. As President of a Lions Club for a full term or a major portion thereof and as a member of the Board of Directors of a Lions Club for no less than two (2) additional years, and
  - b. As Zone or Region Chairperson or Cabinet Secretary and/or Treasurer for a full term or major portion thereof, and
  - c. As Vice District Governor for a full term or major portion thereof Provided, however, that in the event of the incumbent Vice District Governor does not stand for election as District Governor, any club member who fulfills the qualifications of Section 8 of this Article IV and who is currently serving or has served one (1) additional year as a member of the District Cabinet shall be an eligible candidate.
4. With none of the above being accomplished concurrently.

**A Candidate for the office of Vice District Governor shall**

1. Be an active member in good standing of a chartered Lions Club in good standing in his/her Single or Sub-District.
2. Secure the endorsement of his/her Club or the majority of the Clubs in his/her Single or Sun-District.
3. Have served or will have served by the time he/she takes office as Vice District Governor:
  - a. As President of a Lions Club for a full term or a major portion thereof and as a member of the Board of Directors of a Lions Club for no less than two (2) additional years, and
  - b. As Zone or Region Chairperson or Cabinet Secretary and/or Treasurer for a full term or major portion thereof, and
  - c. With none of the above being accomplished concurrently.

**Qualifications for the office of Region Chairperson**

1. Be an active member in good standing of a chartered Lions Club in good standing in his/her Region.
2. Secure the endorsement of his/her Club or the majority of the Clubs in the Region.
3. Have served or will have served by the time he/she takes office as Region Chairperson:
  - a. As President of a Lions Club for a full term or major portion thereof and as a member of the Board of Directors of a Lions Club for no less than two (2) additional years; or
  - b. As Zone Chairperson of a District, or a Cabinet Secretary and/or Treasurer for a full term or major portion thereof;
  - c. With none of the above being accomplished concurrently.

**Qualifications for the office of Zone Chairperson**

1. Be an active member in good standing of a chartered Lions Club in good standing in his/her Zone.
2. Secure the endorsement of his/her Club or the majority of the Clubs in the Zone.
3. Have served or will have served by the time he/she takes office:
  - a. As President of a Lions Club for a full term or major portion thereof and as a member of the Board of Directors of a Lions Club for no less than two (2) additional years;
  - b. With none of the above being accomplished concurrently.
